Welcome to a PVE's Next Generation Camp. The following policies have been put in place to maximize your experience at our camp, and to promote a safe and positive atmosphere.

Failure to observe these standards may result in your dismissal from camp with no refund, and being ruled ineligible for future PVE camps and clinics.

Policies:

- Be on time, and participate in all activities. Only a member of the camp's staff may excuse a camper from their required location and activity.
- Report any medical problems to an appropriate staff member. It is required to report any potential concussion or head injury immediately to an athletic trainer.
- Be courteous and respectful at all times.
- Be where you should be at all times. Only the Camp Director may grant permission for a camper to leave the camp's premise, and only when accompanied by the camper's parent/guardian or a member of the camp staff.
- All facilities and equipment should be used properly, and with care. Any damage or missing items will result in restitution.
- Observe all laws and regulations including, federal, state, town, etc... as well as the host school's (or organization) rules and regulations.
- All fighting, hazing, bullying, or other abusive behaviors are strictly forbidden.
- Cell phones should not be used during guided camp activities unless specifically authorized by a member of the camp's staff or in the event of an emergency.
- No cameras or other forms of photography, video and/or media may be used inappropriately during camp. This includes but is not limited to photographing/recording another individual without their knowledge, or at any time when there is an expectation of privacy (i.e. restroom, shower, etc...).
- No possession or use of alcohol, tobacco, other illegal drugs, firearms, explosives, or other weapons. No smoking of any substances.
- For residential camps, there are to be no overnight guests (campers must stay in their assigned room) and campers are expected to observe all residential rules and regulations including quiet hours. Campers are not to invite or allow guests not directly affiliated with the camp into their room without authorization from camp staff.
- Any other activity that would be deemed inappropriate, dangerous, negligent, or harmful by a reasonable person is strictly forbidden. Observance of such behavior, or any other violation of stated policies should be reported to a staff member immediately.
